There is no fee to sign up for OARRS. The cost associated with accessing OARRS depends upon the salary of the physician assistant, the medical conditions for which the patients are being treated, and the prescribing habits of the physician assistant. A physician assistant who does not prescribe reported drugs will not need to access OARRS.

The physician assistant who prescribes one or more reported drugs is required to register with OARRS.

Failure to comply with the rule could lead to administrative disciplinary action against the physician assistant and/or the supervising physician.

The information gleaned from an OARRS report must be maintained in the patient record but need not be reported to the Medical Board.
