The rule is proposed to clarify requirements and restrictions applicable to use of Scheduled III and IV controlled substances for purposes of weight reduction.

The proposed rule amends the current rule by providing more physician discretion in the use of Schedule III and IV controlled substances for purposes of weight

reduction. Among the changes from the current rule: (1) For controlled subsances for weight reduction that are approved by the FDA for "a few weeks" use, the proposed rule provides for the use beyond twelve weeks when their is supportive evidence documented in the patient's chart; (2) The proposed rule prohibits the use of controlled substances for weight reduction if the patient has received controlled substances for reduction within the past three months; and (3) The propsed rule deletes the requirement that the physician must discontinue use of the Schedule III or IV controlled substances for weight reduction when the patient has failed to lose weight over a 30-day period.
