The proposed revisions to rule 4731-11-04 exceeded fifty percent of the language in the current rule, requiring the current rule be rescinded and new rule 4731-11-04 be adopted.

The rule sets out the requirements for a physician who utilizes schedule II or IV controlled substances for purposes of weight reduction. The requirements include that the physician perform an appropriate assessment and physical examination, that the drug have been approved for such use by the Food and Drug Administration ("FDA"), and restrictions on the length of time the patient may be maintained on the drug if the FDA labeling states that it is indicated for use for "a few weeks."
