This rule addresses qualifications for psychologist licensure (admission to examination for the license). The rule requires numerous changes secondary to amendments to our law in ORC 4732.10 (B)(3)(d) stemming from HB83, which struck a requirement that the board recognize a "degree deemed equivalent to a doctoral degree in psychology or school psychology." That was long ago phased-out in rule, and the last application to be considered as an "equivalent degree" was received in May 2010. Paragraphs (A)-(G) are being deleted because they were all related to the requirements to be met for the board's (no longer existent) "degree deemed equivalent to a doctoral degree in psychology or school psychology." There is also the deletion of reference to the citizenship requirement in 4732.10 (B)(4) because in HB83 that (B)(4) was deleted (citizenship was declared unconstitutional for licensure in 1977). Supervised training in psychological research and teaching at the internship training level are added to (B)(1)(b)(x) and limited to 30% of the training time as is done in (A)(6) for doctoral students and in (B)(2)(d)(xi) for trainees in academic settings wishing to use up to 30% of training time in research or graduate teaching of applied psychology.

In the introductory paragraph there was an old reference to RC 4732.10(B)(4)(d) that was changed to (B)(3)(d) because there is no longer a (B)(4). In paragraph (C) RC 4732.10(B)(4)(c) was changed to (B)(3)(c). Also, there was an inadvertent deletion of a statutory option for license eligibility and it was reinstated in the amended rule body--RC 4732.10(B)(3)(b) continues to be an option for applicants with degrees earned outside of the US and Canada.
