This rule contains details about meeting the requirements for the psychologist license, focused on the training requirements. The proposed amendments in (D) specify the reciprocity requirements from SB131. Other small changes relate to retaining the "senior psychologist" license pathway--which now only applies to Canadian psychologists. Prior to SB131, there was a requirement of 10 years of licensure in another state or Canadian province. With SB131 lowering that to one year for those in the US, this leaves the Canadians at 10 years.
