This rule is being proposed as a result of Sub SB 33(Schuring), 127th General Assembly.

Requires licensees to maintain an active chiropractic license in order to possess an acupuncture certificate; requires when a chiropractic license is suspended, revoked,

placed inactive or forfeited, that the certificate to practice acupuncture shall be suspended, revoked, placed inactive or forfeited. Prohibits a chiropractic physician from holding an active acupuncture certificate without an active chiropractic license.
