The rule details the requirements for veterinary technicians (RVT) registration, duties, and continuing education.

The amended language is in response to HB 509 of the 134th General Assembly which removed the requirement for a picture upon initial application. The enacted bill also reduced the fees for RVTS but eliminated the instructions for an RVT to renew after March 1st of the odd year. The amended rule provides the instructions for renewal after the due date. The rule also removes the "must be of good moral character" in keeping with the mandates of HB 263 in the 134th General Assembly.

The fee for an initial and renewal of an RVT license is \$35 currently. Renewing after March 1st in the odd year, a \$10 late fee is assessed. After April 1st in the odd year, the RVT is charged a \$25 late fee.

The late fee assessed after the renewal deadline is meant to deter RVTs from renewing late and be in compliance with the Veterinary Medical Practice Act as they assist with surgeries, access and administer controlled substances, etc.

The registered veterinary technician must be licensed to perform specific duties as outlined in R.C. 4741.19 that requires supervision by a veterinarian.
