The Board proposes to amend this rule to achieve the following:

- 1. Increase the required age to qualify to be a nursing home administrator from 18 to 21, which corresponds to a change H.B. 166 made when revising R.C. §4751.06, which H.B. 166 also renumbered to be §4751.20.
- 2. Replace "master degrees" with "master's degrees."
- 3. Replace "he or she" with "the applicant."
- 4. No longer require supplemental documentation to be "properly notarized."
- 5. Delete paragraph (B)(4), which requires fees to accompany application forms.

Additionally, the Board proposes to update the "rule amplifies" section of this rule to correspond to the renumbering of R.C. Chapter 4751. of the Revised Code by H.B. 166 (133rd G.A.).
