House Bill 131 permits the Board to begin licensing foreign-trained physical therapist assistants. This rule implements that law. Also five year review.

Page 2 Rule Number: **4755-23-12** 

The rule details the requirements to be licensed as a physical therapist or physical therapist assistant in the state of Ohio. Establishes requirements for foreign educated PTAs which must be met in order to obtain licensure. These requirements are identical to the requirements for PTs. The rule also raises the minimum score required on the Test of English as a Foreign Language exam in order to achieve licensure. This change will make Ohio's minimum required score be equivalent or higher than what will be required by the Federation of State Boards of Physical Therapy in order to take the National Physical Therapy Exam.

The PT Section decided to withdraw the changes to the minimum required TOEFL scores. These increased score requirements were based on a proposed change by the entity which provides the National Physical Therapy Examination. Those proposed changes have been withdrawn and the Section followed suit.

10/08/2019 The change eliminates certain documents from those which are accepted to prove educational equivalence when educated in a foreign program. The documents listed are meant to be used for immigration purposes, not licensure.
