This rule details the requirements needed to apply for initial licensure as an occupational therapist or occupational therapy assistant in Ohio. The new rule will has a change which aligns OTPTAT Board rule English language requirement to the criteria used by the National Board of Certification for Occupational Therapy (NBCOT) to evaluate internationally educated individuals with respect to obtaining a Visa Credential Verification Certificate.

This new rule also adds a requirement initial applicants for licensure to view a short informational video about the Board's Safe Haven program.

It costs approximately \$800 (at least) to gather materials related to licensure when a person has been educated in a different country. These costs are required to comply with the Ohio Revised Code, which requires educational equivalence.
