For most applicants out of practice between 5 and 9 years, additional requirements typically include completion of the AOTA online continuing education activity titled "Occupational Therapy in Action: Using the Lens of the Occupational Therapy Practice Framework, 2nd Edition." As specified on the AOTA website, the cost for this activity is \$180 for members of AOTA and \$255 for non-members. In addition to this activity, applicants are required to complete a period of supervised clinical practice. The applicant receives a limited license to complete the clinical practice and can be employed and earn a salary during this component of the re-entry process.

For applicants out of practice for more than 10 years, repassing the NBCOT certification exam is often required. According to the NBCOT website, the fee to sit for the exam is \$540, plus a \$40 fee to have the scores sent to the Ohio Board.
