Individuals submitted an application for licensure must pay a fee of \$100.

All individuals seeking to practice athletic training in Ohio must obtain a license from the Board.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? **Yes**

If an individual does not submit an application, they cannot get a license to practice. Individuals practicing without a license are potentially subject to criminal sanctions.

Individuals must pay the \$100 application fee.
