Under the current rule, a reinstatement applicant is required to have the full number of hours of CE required for a renewal. The amendment states that if an individual applies for reinstatement within 1 month of the date that the license expired, the

reinstatement CE required will be the same as the amount of CE that was required for the renewal that just passed. If an individual's license was valid for less than one year, the renewal rules state that the amount of CE is halved. For these individuals, their reinstatement CE requirement would also be half the full amount required.
