The amendment states that applicants for license reinstatement must submit proof that the applicant holds current certification by the Board of Certification if the reinstatement application is submitted on or after December 1 of the year in which the license expired.

Although most athletic trainers maintain their BOC certification even if their license is expired, there are some costs associated with reinstating the certification if it has expired. If the certification is expired for less than two reporting periods (typically 4 years), the process is a \$100 fee and completion of the appropriate number of continuing education activities. If the certification is expired for two or more reporting periods (more than 4 years), the individual must retake the BOC certification exam. The cost for that process is \$60 application fee and \$300 for the exam. These fees are in addition to the \$100 reinstatement application fee that the individual pays to the Board to reinstate the expired Ohio license. All individuals seeking to practice athletic training must obtain a license from the Board.

If an individual practices without a license, they would be potentially be subject to civil or criminal penalties.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? **Yes**

Applicants seeking to reinstate an expired license must pay the \$100 reinstatement application fee to the Board. They would also potentially need to pay fees to the Board of Certification to reinstate their national certification if that credential had also expired.
