The proposed change reduces the amount of continuing education required to renew an athletic training license from 50 hours every two year to 25 hours every two years. The amendment also states that anyone whose first Ohio license was issued

within 12 months of graduation from an accredited entry level athletic training education program is not required to complete CE for the first renewal. The rule also states that CE credit may be awarded for graduation from a post-professional AT program accredited by the National Athletic Trainers Association. Finally, the rule removes the provisions awarding continuing education credit for CPR and first aid certification.
