This rule outlines the supervision requirements for occupational therapy personnel. The current rule includes a provision stating that one occupational therapist (OT) can supervise no more than four occupational therapy assistants (OTA). The proposed amendment to the rule removes the supervision ratio. As a result, an OT would use their professional judgment and the unique circumstances impacting their practice to determine the appropriate number of OTAs that may be safely supervised.
