The proposed change could reduce a potential financial burden if a licensee held the active Ohio license for less than one year. The individual might have 12 contact hours of continuing education in a category that is capped at 10 hours. Under the current rule, the individual in that situation would need to obtain 2 additional hours, which will likely be at some cost for the activity. This change would eliminate the need for additional coursework in that kind of situation.
