A.) Does this rule require a license, permit, or any other prior authorization to engage in or operate a line of business? Yes

All individuals seeking to practice occupational therapy in Ohio must hold a valid license from the Board. This license must be renewed biennially. As part of the renewal process, licensees are required to complete 20 contact hours of continuing education.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? **Yes**

If a licensee does not complete the required 20 hours of continuing education, they cannot renew their license. If they renew, but did not complete the 20 hours, they are subject to disciplinary action for not complying with the CE requirement.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? Yes

Many continuing education activities have a cost to register/complete. This cost is borne by the licensees completing the activity.
