There are two main changes to the continuing education rule being proposed. The first change states that licensees are not required to complete continuing education for the first renewal. The second change will allow for CE credit for supervision of a Level I fieldwork student. Under current rules, a licensee can only earn CE credit for supervising a Level II fieldwork student.
