House Bill 509 eliminated the temporary license for orthotics prosthetics, and pedorthics. This rule is proposed as part of the implementation of that legislation.

Explains the process of obtaining a license for orthotics, prosthetics, and pedorthics. The rule change eliminates references to temporary licenses and supervision that were eliminated in House Bill 509 and clarifies in more general terms how to enroll in eLicense Ohio.
