Significant changes to the education requirements that specific Council on Accreditation for Counseling and Related Educational Programs, "CACREP", accredited degree programs automatically are accepted as meeting licensed professional counselor education qualifications. Further, all Ohio mental health counseling programs have to be CACREP clinical mental health accredited by 1/1/2018 for their students to meet licensure education requirements. Also, deletes the requirement for non-CACREP accredited degrees to have 20 semester hours in specified clinical courses, but clinical coursework is still required without specifying the number of hours.

Licensure fees are \$60 for licensed professional counselors per rule 4757-1-05 of the Administrative Code. A master#s degree can cost anywhere from \$30,000 to \$75,000 depending on the school attended based on tuition costs. The licensure exam for licensed professional counselors is \$180 per contract with the provider. The cost for the criminal records check is \$22 for the BCI and \$24 for the FBI, plus a processing fee that may be charged by the entity processing the fingerprints. Out-of-state non-CACREP graduates may have to take additional coursework in order to meet the requirements for licensure, which can be from three to twelve semester hours with costs of \$450 to \$750 per credit hour as well as lost income due to inability to practice until licensed.
