Licensure fees are \$60 for social workers per rule 4757-1-05. A bachelor's degree at the current tuition and fee charges cost \$34,000+ from Ohio State University, assuming graduation in four years attending a regional campus for two years and two years at main campus. All four years at main campus would be over \$40,000. A master's degree can cost anywhere from \$21,000 to \$80,000 depending on the school attended based on tuition costs. The licensure exam for social workers is \$230 per contract with the national provider. The cost for the criminal records check is \$22 for the BCI and \$24 for the FBI, plus a processing fee that may be charged by the entity processing the fingerprints.
