Cost of compliance only becomes an issue if licensees fail to adhere to the ethical standards. Failure could result in loss of license, suspension or other disciplinary action. These standards are referenced on the board's web site and part of all licensees training in their degree programs. The board requires three hours of continuing education in ethics for renewal of licensure every two years.
