Rule requires licensed professional counselors and license professional clinical counselors to complete 30 hours of continuing education to renew their licenses in an active status. Licensees who renew per rules 4757-9-02 of the Administrative Code pay fees of \$75 for independent license, \$60 for dependent licenses.

The continuing education (CE) course vary from free to hundreds of dollars depending on the source and quality of the programs. Many employers offer CE courses without charge, ODMHAS offers drug and alcohol CE course for free online and there are many online low cost alternatives. The licensees have to complete 30 CE hours per renewal unless they elect inactive status once that is up and operational. With average courses costing about \$10 per hour that would be \$300 for many licensees not getting training through their employer or other low cost alternatives.
