Rule establishes course content requirements for continuing education providers. Their cost is driven by ensuring the course content meets the requirements stated in order to gain board approval of their courses. The supervison requirement will require three hours of the thirty required continuing education hours bienially be in supervison for LISWs that hold a supervison designation. Cost of compliance may be higher if the approved continuing education courses in supervison are more expensive than other courses the licensee may have taken instead. Course costs vary from free provided by the employer to minimal through an association to very expensive if you take a nationally known author or practitioners course.
