This rule is being adopted as part of a comprehensive review and reorganization of several EMS rules. This reorganization will allow readers greater ease in accessing and understanding the rules in Chapters 4765-1 to 4765-19 of the Ohio Administrative Code. This rule was previously numbered 4765-6-05, which is being rescinded and renumbered as 4765-17-01.

This rule outlines the required curriculum for EMT-paramedics for initial certification and refresher training. This rule is being created from language removed from 4765-6-05 to make the rules more convenient for the user.

This rule is in compliance with the exception of R.C. 121.75 (E) because: the incorporated curriculum is a generally accepted standard familiar to EMTs, the incorporated curriculum is available via the identified NHTSA web site and most EMTs or their organizations have access to a computer, the incorporated curriculum is intelligible to EMTs who are enrolling in and/or teaching a class, and the rule includes the applicable version (date) of the incorporated curriculum.

This rule is being adopted as part of a comprehensive review and reorganization of several EMS rules. This rule was previously numbered 4765-6-05, which is being rescinded and renumbered as 4765-17-01. As such, there is no additional cost of compliance. EMT-paramedics must still pay for the cost of the EMT-paramedic course, which is approximately two thousand dollars (\$2,000); however, the amount will vary by location. EMT-paramedics required to take the refresher course must pay approximately four hundred dollars (\$400), although the amount will vary by location. There is no cost to county or municipal governments unless they choose to pay the costs for the individual EMT-paramedic; these costs may then be offset by grant money from the Division of EMS.
