This rule is being filed in order to update the scope of practice for EMT-paramedics and in conjunction with new rule 4765-6-04 (which allows an expanded scope of practice pursuant to a board-approved research study).

New language references new rule 4765-6-04 (the research rule) as being additional

services that an EMT-paramedic may perform. Additionally, paragraph (C) was included to clarify that certain services may not have been originally included in initial training for EMT-paramedics who were certified several years ago. In those instances, the EMT-paramedic's medical director can approve such training, provided it is within the EMT-paramedic's scope.
