4765-17-03 **EMT-paramedic Paramedic** scope of practice.

- (A) In addition to the skills listed in rules <u>4765-12-04</u>, 4765-15-04 and 4765-16-04 of the Administrative Code, and in accordance with section 4765.39 of the Revised Code, an <u>EMT-paramedic a paramedic</u> may perform the following emergency medical services only pursuant to the written or verbal authorization of a physician or of the cooperating physician advisory board, or authorization transmitted through a direct communication device by a physician or registered nurse designated by a physician, or in accordance with written protocols as specified in division (C) of section 4765.39 of the Revised Code:
 - (1) Tracheostomy tube replacement and suctioning;
 - (2)(1) Orotracheal intubation;
 - (3)(2) Nasotracheal intubation;
 - (4)(3) Cricothyrotomy (surgical);
 - (5)(4) Cricothyrotomy (needle);
 - (6) Dual lumen airway;
 - (7) Supraglottic airway;
 - (5) Positive end-expiratory pressure;
 - (6) Bilevel positive air pressure;
 - (8)(7) Ventilatory Ventilator management of patients sixteen years of age or older;
 - (8) Chest tube monitoring and management;
 - (9) Central line monitoring;
 - (9)(10) Transcutaneous cardiac pacing;
 - (10)(11) Administration of cardiac medication;
 - (11)(12) Cardioversion;

(13) Carotid massage;

(12)(14) 12-lead <u>Twelve-lead</u> electrocardiogram performance and interpretation;

- (13)(15) Administration of nitroglycerin;
- (14)(16) Administration of <u>aerosolized or</u> nebulized medication;
- (15) Needle decompression of the chest;
- (16)(17) Placement of nasogastric or orogastric tubes;
- (18) Administration of cardiac medication;
- (17)(19) Administration of other medications pursuant to written protocols;
- (18)(20) Intravenous infusion pump-:

(21) Blood chemistry analysis;

- (22) Thrombolytic therapy initiation and monitoring:
- (23) Maintenance of medicated intravenous fluids;
- (24) Maintenance of blood administration;
- (25) Eye irrigation morgan lens;
- (26) Withdraw blood for the purpose of determining the alcohol, drug, controlled substance, metabolite of a controlled substance, or combination content of the whole blood, blood serum, or blood plasma as provided in division (D) of section 4765.39 of the Revised Code when performed in accordance with the criteria established in rule 4765-6-06 of the Administrative Code and the protocols established by the medical director of the emergency medical service organization with which the EMT-paramedic paramedic is affiliated-;
- (27) Any other services pursuant to a research study approved by the board under rule 4765-6-04 of the Administrative Code and within the parameters established by the board for such study.
- (28) Any other services approved by the board pursuant to rule 4765-6-01 of the Administrative Code.
- (B) A physician or cooperating physician advisory board that serves as the medical director for any EMS organization may limit, but not exceed, the scope of practice for those <u>EMT-paramedics paramedics</u> who provide emergency medical services under the auspices of the physician's certificate to practice medicine and surgery, or

osteopathic medicine and surgery, issued under Chapter 4731. of the Revised Code to include the withdrawing of blood for evidence collection.

(C) An EMT-paramedic <u>A paramedic</u> shall not perform emergency medical services within this rule unless the <u>EMT-paramedic paramedic</u> has received training as part of an initial certification course or through subsequent training approved by the board. If certain emergency medical services, within the <u>EMT-paramedic</u> <u>paramedic</u> scope of practice, were not included in the training specified in this paragraph, the <u>EMT-paramedic paramedic</u> must have received training regarding such services approved by the local medical director before performing those services.
