**EMS instructor seeking fire service instructor certification.****RULE SUMMARY**

6. State the reason(s) for proposing (i.e., why are you filing,) this rule:

This rule is being filed pursuant to a completed R.C. 119.032 five-year rule review. This rule is being proposed for rescission due to LSC's fifty percent guideline. It is estimated that changes to the rule strike approximately half of the existing text while adding a comparable amount of new text. This rule is simultaneously being proposed as a new rule under the same rule number.

This rule sets forth the certification process for a certified EMS instructor to obtain a fire instructor or fire safety inspector instructor certification.

This rule incorporates an agency application. While the application is commonly known and has been made generally available to affected persons via EMS' website, this rule did not originally address the materials in compliance with sections 121.71 to 121.74 of the Revised Code. This rule is simultaneously proposed for rescission and adoption under this same rule number, in part, to address these materials. The new rule, under this same rule number, will refer readers to rule 4765-11-01(N) (See filing package 114977) where all materials incorporated by reference in Chapter 4765-11 and Chapters 4765-20 to 4765-23 are appropriately addressed including date/version of materials, as well as availability.

In compliance with R.C. 121.73, the agency form, correctly entitled "Fire, Assistant Fire, and/or Fire Safety Inspector Instructor Initial Application," is being filed as part of new rule 4765-11-01 (See filing package 114977), which addresses the version/date of incorporated materials, as well as where they may be accessed.

This rule is being rescinded and simultaneously proposed for adoption under this same rule number. This rule sets forth the requirements that must be met for an EMS instructor to obtain a fire instructor certificate, which pursuant to rule 4765-20-01, is required prior to engaging in fire service instruction, to be approved for reinstatement.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? **Yes**

This rule is being rescinded and simultaneously proposed for adoption under this same rule number. However, failure to comply with the terms set forth in this rule may have resulted in an application for fire instructor or fire safety inspector instructor to be denied.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? **Yes**

This rule is being rescinded and simultaneously proposed for adoption under the same rule number. As it sets forth the certification process for an individual issued an EMS instructor certificate by the EMFTS Board to obtain a fire instructor or fire safety inspector instructor certification issued by the Executive Director, it is estimated that applicants typically incurred tuition costs of approximately from \$300 to \$500.
