Rule 4765-3-05 sets forth the requirements for each emergency medical director, which include possession of a valid Ohio medical license; active involvement in the provision of emergency medical care and with one or more EMS organizations; evidence of high ethical standards and no conflicts of interest; and appropriate

board certification. The rule sets forth the location to access medical director courses approved by the EMFTS Board and qualifications and procedures to seek the position of medical director. The rule is amended to add "in good standing" in paragraph (A)(1), describing the valid Ohio medical license requirement and to update the Web address for board-approved medical director courses.
