This rule sets forth the requirements for a medical director. Former language establishing a 3 year phase-in period (in the original filing) for all medical directors has been removed as it is no longer necessary. New language also requires current medical directors who are not board certified by American Board of Emergency Medicine (ABEM) or American Osteopathic Board of Emergency Medicine (AOBEM) or board eligible through residency program recognized by American Board of Medical Specialties (ABMS) or American Osteopathic Association (AOA), to complete a medical directors course through the National Association of Emergency Medical Service Physicians (NAEMSP), Ohio Chapter of American College of Emergency Physicians (OACEP), or other equivalent course approved by the EMS Board and submit verification of their experience as a medical director and performance improvement programs or training. Lastly, new language requires new medical directors who are not board certified by ABEM or AOBEM or board eligible through residency program recognized by ABMS or AOA, to complete a medical director course as previously noted and request a waiver.
