This rule is being proposed to reflect changes to the emergency medical provider titles pursuant to H.B. 128, 129th General Assembly, and nationally recognized industry standards.

This rule sets forth the continuing education course requirements for accredited or approved institutions to include the following: each course must be taught by a certified instructor, each institution must issue a certificate completion for each course, and courses must be at least one-half contact hour. The rule also establishes acceptable formats of education (online education, independent study, traditional classroom, etc.). This rule is being amended to change "first responder and EMT" to "EMS provider." EMS provider is the collective term for all levels of emergency medical responders and EMTs.
