Ohio Adm.Code Chapter 4901:1-10 is intended to promote safe and reliable service to consumers and the public, and to provide minimum standards for uniform and reasonable practices. Ohio Adm.Code 4901:1-10-03 consists of record retention standards that the above entities must follow.

The revisions to this rule were made to comply with R.C. 121.951. The revisions removed unnecessary regulatory restrictions from the rule, such as removing the word "shall" when it was not needed.

This rule assumes that the entity qualifies as an investor-owned electric utility or transmission owner. To operate within this field, there are several regulatory hurdles to clear to do so.

B. Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? Yes

Yes. This rule requires that electric utilities and transmission owners must provide adequate service and facilities, as prescribed by the commission, and must comply with laws of this state. Therefore, if an entity fails to follow these requirements then it creates a cause of action that a consumer can pursue and/ the Commission can address.

C. Does this rule require specific expenditures or the report of information as a condition of compliance? No

No. This specific rule does not.

D. Is it likely that the rule will directly reduce the revenue or increase the expenses of the lines of business of which it will apply or applies? Yes

Yes. This rule requires that electric utilities and transmission owners must provide adequate service and facilities, as prescribed by the commission,
