Reference to a residential treatment center certified by ODADAS was removed so that an individual residing in any residential treatment center meets the living arrangement for DFA purposes but the individual must have met one of the covered categories for DFA, disabled as determined by County Medical Services (CMS) or age 60 or over and received DFA in June 2003.
