This rule is being updated to clarify policy as it pertains to the administration of the Child Care Program.

This rule outlines the initial and on-going training and professional development requirements for providers, staff and substitutes. This rule is being amended to remove paragraph (A)(3) that requires providers that are already licensed to meet the health training requirements and paragraph (C)(2) that requires child care staff members already employed to complete the one hour child abuse and neglect overview by June 30, 2017. This rule is also being amended to clarify that the training documentation only has to be given to employees if it is not stored in the Ohio Professional Registry (OPR) and to clarify language for substitute child care staff members and their training requirements.
