This rule is being proposed for amendment to implement Am. Sub. HB 153, 129 General Assembly, relating to the administration of the licensed type A home child care program. This rule is also being proposed for amendment as a result of the Five Year Review.

This rule contains the type A home requirements for supervision of children and the staff/child ratios in licensed homes. This rule has been amended to establish supervision requirements for times when children are out of sight of the child care staff member, to replace the staff/child ratio paragraphs with a chart outlining the required ratios, and the limitation of caring for no more than three children under 2 years of age has been revised to caring for no more than three children under age 18 months. Additionally, the rule has been amended to include that the child care staff member responsible for a child shall record the attendance for that child, that it shall not only be the administrator's responsibility to maintain the record.
