This rule is being proposed for amendment to revise and add definitions for the implementation of the statewide automated child care eligibility, authorization and payment system.

This rule provides definitions for eligibility for publicly funded child care benefits. It is being amended to add definitions for: adjustment, authorization, case, deduction, eligibility period, household and step up to quality, and to clarify definitions for: deposit, eligible provider, in loco parentis, minor child, registration fee, school child and school hours. The definitions of certificate of authorization for payment of publicly funded child care services and reimbursement rate were deleted.
