This rule is being amended to integrate Publicly Funded Child Care (PFCC) into the Ohio benefits integrated eligibility system.

This rule outlines the application process and eligibility requirements for publicly funded child care benefits. Updates to this rule include language edits to align with terminology used in the statewide automated eligibility system, clarification of minor parent caretaker eligibility, clarification of the PFCC joint application process, replacing the JFS 01138 "Application for Child Care Benefits" with the JFS 07200 "Application for SNAP, Cash Assistance, Medical Assistance, or Child Care Assistance" and the JFS 01124 "Re-determination Application from Child Care Benefits" with the JFS 07204 "Request to Reapply for Cash Assistance, SNAP and/or Child Care", the addition of electronic education as a qualified activity and clarification of what documentation can be used to verify a child's citizenship.
