This new rule is being proposed to replace rescinded rule 5101:2-16-41 to group regulations according to topic and to renumber the rules consecutively as part of the five year rule review.

This rule sets forth the payment rates and procedures for providers of publicly funded child care (PFCC) services. The following changes were made:

1) Changed to the question and answer format.

2) Clarified how rates for providers are established.

3) Clarified that categories of authorization are based on the total number of weekly child care hours approved for publicly funded child care.

4) Clarified that payment is made based on the total number of child care hours provided in a week, not to exceed the child's category of authorization.

5) Clarified how providers are compensated for caring for children with special needs.

6) Added requirements for Ohio department of job and family services payment of registration fees for children in care.

7) Updated Appendix A to the rule to reflect new provider payment categories and rates.
