H.B. 166 of the 133rd General Assembly, to add that the rule is amended due to the passage of this legislation, to add clarification regarding what happens if the Ohio Department of Job and Family Services determines misuse of publicly funded child care as a result of a Program Integrity Review, and in paragraph (E) the word "either" was changed to "both" for clarification.
