This rule has been amended for reformatting purposes in order to provide clarity regarding the role of the MEPA Monitor and enforcement requirements whenever an agency employee or contractor engages in discriminatory acts, policies, or practice involving RCNO. The rule has been amended to update the revised dates of forms and paragraph referenced in the rule. Finally, the rule has been amended to clarify when agencies are to submit the JFS 1420 "Multiethnic Placement Act Corrective Action and Resolution Plan Data Collection Requirements."
