This rule sets forth timeframe requirements and when to complete a "Family Assessment".

The rule was amended to change all system references to Ohio's comprehensive child welfare information system (CCWIS) to align with the federally recognized case management information system to support child welfare program needs.

Timeframes to complete the report disposition and arrive at a final case decision was changed from forty-five to sixty days throughout Chapter 5101:2-36 rules, therefore, completion of the "Family Assessment" has been aligned with the assessment/ investigation timeframes of sixty days.

5101:2-37-03 (C) The PCSA shall complete the "Family Assessment" regarding the family of the alleged child victim/child subject of the report.

5101:2-37-03 (D) If an order of shared parenting has been issued and there has not been a residential parent designated by the court, the PCSA shall complete the "Family Assessment" on the family members residing with the custodian who has physical care of the alleged child victim/child subject of the report at the time the incident occurred.

5101:2-37-03 (F) The PCSA shall complete the "Family Assessment" no later than forty-five days from the date the PCSA screened in the report.
