This rule also incorporates the course of actions that shall be taken by an assessor when an applicant knowingly falsifies information, initiates a homestudy or will adoptively place a child.

Language has been added to paragraph (A) to indicate that ODJFS will search the central registry for PCSAs, PCPAs and PNAs and provide a summary report to the agency regarding adoptive applicants and other adult household members to assist in their evaluation to approve the applicant as approved adoptive applicants.

In paragraph (A)(2)(c) the word "collateral" contact has been added.

In paragraph (B) replaced the "PCSA, PCPA and PNA" with the word "agency".

In paragraph (B)(2)(e) the spelling of the word "prospective" has been corrected.

Paragraph (B)(4)(c) has been revised to specify that foster children and children in kinship care are also included in the count of the total number of children residing in the home when determining when a multiple children assessment must be completed.
