rule is amended to add language requiring public children services (PCSAs), private child placing agencies (PCPAs), or private non-custodial agencies (PNAs) operating a foster care program to include in its foster care policy a copy of the JFS 01611 "Non-discrimination Requirements for Foster Care and Adoptive Placements." The rule also includes a standard of conduct regarding non-discrimination in the foster care process.
