This rule establishes the maximum rate of reimbursement for services provided through the PASSPORT Medicaid waiver program. Am. Sub. HB 119 (127th GA) contains language increasing the maximum rate of reimbursement for PASSPORT Medicaid home and community based services waiver providers by three percent in state fiscal year 2009. This rule change implements that section of the legislation.
