- 1) A new paragraph (A) has been drafted to establish that the Ohio Department of Aging is the State agency responsible for the day to day administration of the PASSPORT waiver pursuant to an interagency agreement with the Ohio Department of Medicaid.
- 2) A new paragraph (B) has been created to establish that the PASSPORT waiver is available to eligible individuals who meet an intermediate or skilled level of care as defined in the Ohio Administrative Code.
- 3) New paragraph (D) has been modified to reflect an September 27, 2013 effective date:
