This rule is being amended to update the policies surrounding the PASSPORT program. The amendment adds the billing maximum for a component for Emergency Response System Services covered by the PASSPORT program. This Appendix is being updated to reflect changes in Ohio Department of Aging Rule 173-39-02.6 Emergency Response Systems to add reimbursement rates for this service to the PASSPORT covered services included under Emergency Response Systems.

This rule lists the set of services available through the PASSPORT program and their rates which include billing units and billing maximums.
