This rule is being proposed for five year rule review.

The rule is also being amended to implement a policy change in HB 153 (129th GA) that modifies the eligibility and enrollment processes for the Assisted Living waiver program.

This rule establishes the enrollment process for the Assisted Living waiver program.

The rule is being amended to:

- 1) Delete requirements that prevent consumers living in the community to enroll in the waiver;
- 2) Make technical and grammatical changes as well as update ODJFS application form information;
- 3) Clarify that enrollment in the Assisted Living waiver shall occur in accordance with the waiver's home first process and rule 173-37-03 of the Administrative Code;
- 4) Indicate that if a waiting list exists in the Assisted Living waiver, enrollment in the waiver shall occur in accordance with rule 173-44 of the Administrative Code; and
- 5) Delete language pertaining to a consumer's Assisted Living waiver eligibility determination as that topic is addressed in rule 5101:3-33-03 of the Administrative Code.
