This rule describes the process of initial interviews for SNAP. Proposed changes to the rule include amending paragraph (D)(9) to align with federal regulations and clarify that during the interview county agencies are to screen each individual who is either an adult or a sixteen or seventeen year old who is the assistance group name and is not in school or in the SNAP E&T program, to determine if an individual is required to register for work and for appropriateness for referral to the SNAP E&T program, by using the JFS 07208, "Supplemental Nutrition Assistance Program Work Registration, ABAWD, and Employment and Training Screening Tool" or other automated system equivalent approved by the Ohio department of job and family services (ODJFS).
