Such hearings are for the recovery of Medicaid overpayments for programs administered by other agencies on behalf of the Ohio Department of Job and Family Services (ODJFS) pursuant to an interagency agreement.

Changes to the rule include correcting a typographical error, adding clarifying language concerning referral to the attorney general, and correcting a citation. There are no changes to policy or procedures.
